## OFFICIAL BOARD SUMMARY

December 4, 2014



The monthly Official Board meeting was called to order by Co-Chair Bill Koellner. In attendance were: Co-Chair Tom Probst, Syd Harned, Karen Nortman, Margaret Barnhart, Ken Noble, Joe Myers, Susie Lehman, Pastor Marian Hart, Treasurer Keith Barnhart and Clerk of session Katie Thrasher. Those not in attendance were: Darren Brooke, Jan McCrabb.

**Devotion** – Pastor Marian read from the Gospel of John  
**Open in Prayer**

**Approval of Docket:** move to approve docket as amended 1st Ken N. 2nd Joe M. unanimously approved by the Board.

**Approval of Nov. Minutes:** move to approve minutes 1st Ken N. 2nd Karen N. unanimously approved by the Board.

### Treasurer's Report:

Keith Barnhart gave the Treasurer's report. All bills paid in November. Gave Joe M a check for Welcome Table from a previous year. MidWestOne Bank gave Susie L. a \$100 check for playing at the Holiday Open House that will go into line #502. Bill K. reports that all of the pledges for the kitchen will be into the church by mid-December. That will mean 100% of kitchen pledges will be turned in. Personnel salaries were discussed giving Keith all the information he needs to complete the 2015 budget.

Move to approve Treasurer's report 1<sup>st</sup> Tom P., 2<sup>nd</sup> Ken N. unanimously approved by the Board.

**Co-Chair's Report:** The new kitchen has proved to work very well, as not only has it been used for Sunday coffee hours, but the Johnson Family friends used it extensively for meat preparation for Emily & Jesse's wedding. As of this writing (12/1), we plan on 30 at FCU and 54 at ELC for the 12/6 start of Welcome Table. Beginning the last quarter of 2014, \$5600 in pledges remained to be paid. As of December 1, only \$1600 remained to be paid. Those families plan on all gifting for the kitchen project by mid-December. The board was able to pay for all the concrete work with funds transferred from Board endowment funds.

The remodeled single restroom has been made into a handicap restroom by the end of the first week of December thanks to Darren and Dillon Brooke.

Food items are beginning to fill the hallway by the food pantry in preparation for the Christmas Box food and toy program. The sorting and filling of the boxes will be done on December 17 at 6:00 PM, and pickups will be on December 19 and 20. If you want to help, it is a great program to serve others.

The start of the 2014 church year was financially difficult as income was far less than expenses. I looked at the last 4 years of weather, and this is what I found: The winter of 2011/12 we were 1000 degree days warmer than normal and had only 4 snows that required snow removal; winter of 2012/13 we had a normal temperature winter with only 4 snows that required snow removal; but last winter we were 1100 degree days colder than normal and we had 17 snows that required snow removal. The tremendous expense for heat and snow removal used most of our checking account cash. In addition, we had insurance and per capita mission to the Presbyterian Church in January, taking much of our savings. November 2014, we were 226 degree days below normal, but we had only 1 snow removal. This is the coldest November in over a decade. Depending on the December through March, we have started into another very cold winter.

I want to thank all committees for your helping our church become a wonderful place to worship our God and His Son Jesus Christ. I also want to thank all the

church committees for their service in 2014. Please come to the Annual Meeting in January to learn more about what occurred in 2014.

Jason Thrasher, as CE Director, will have an increase in pay for a total of \$15/hour, \$250/mileage, \$100/Continuing Ed., no change for any other staff. Vote to approve budget to be presented to Congregation at the Annual Meeting on January 11<sup>th</sup> 1<sup>st</sup> Syd H., 2<sup>nd</sup> Tom P. unanimously approved by the Board.

Bill K. asked if the Presbytery Per Capita needed to be paid in early 2015 or if it could wait till the bills for the cold/snowy months had been paid. Keith B. and Pastor Marian say it can be paid anytime during the year.

**Endowment Report** – Joe M. reports that New Covenant Fund has shown no movement at all for the 3<sup>rd</sup> quarter. Joe has called twice with no results or answered questions. Joe has now written a letter that he asks Bill K. to cosign with Joe asking for an answer to lack of information communicated.

**Leadership Retreat** – Pastor Marian explained there will be a leadership retreat January 9, 10 at Camp Wyoming's Owl Nest. Speaker will be Pam Mumm on Saturday. We will share the cost with two other churches for the speaker (ours is \$220) and each person will be about \$44 per person for meals and lodging. Pastor Marian suggests we use discretionary funds from Fund A to cover costs. The Board is invited as well as anyone interested in being more of a leader in the church.

**PASTORAL RELATIONS NOV. 2014**

The Pastoral Relations Committee met with Marian Hart on Wednesday, November 19 in order to discuss the results of her performance review. The committee had gathered input from 10 active church and Board members using the tool provided by previous committees. The committee as well as Marian felt that the ratings from the congregation were an accurate reflection of Marian's practice.

Some strengths indicated in the evaluation:

1. Marian has a deep dedication to the church and it's members. She is good at calling on those that are ill, shut-in or those that just need a visit.
2. Marian models mission. She has a deep desire to give to others. This is modeled on a regular basis.

Some indicators for growth:

1. Marian has a very laid back leadership style. It was noted that she could be a bit more assertive in getting committees up and running and to check on their progress.
2. Marian has been working to refine her sermon delivery. She could improve on making eye contact, voice inflection and smiling.

Marian and the committee will investigate ways to bring about changes in leadership style.

**CHRISTIAN ED. REPORT:**

Hello from the Christian Education Department, We are truly blessed at First Church United to have a wonderful group of children. They are learning the Scriptures at their own level and applying it to become people of faith. Each day we are together we celebrate God's glory through education, practice of being good, and song.

Our big project currently, of course, is learning to be worship leaders by practicing for the Christmas play. The children are working very hard at learning their

lines, memorizing the songs and understanding what the play is about.

It is a traditional Christmas play celebrating the birth of Jesus. It has been a great joy seeing the light of revelation on the faces of the children as they come to understand the history of Jesus' birth through the rehearsal of this story. The children will lead worship this upcoming Sunday, December 7 via this play. We hope you can all attend!
